

**INTERNATIONAL KINDERGARTEN AND PRE-SCHOOL
EDUCATIONAL INSTITUTIONS STEAM PROJECT
„EASTER DECORATION“**

REGULATIONS

I. GENERAL PROVISIONS

The regulations of the STEAM project of international kindergarten and pre-school education institutions „Easter Decoration“ (henceforth referred to as project) provisions regulate the goal of the project, the responsible personell, the participants and the organizational and executive procedures.

II. GOAL AND TASKS

Goal: to develop the awareness of sustainable use of kindergarten and pre-school age children by applying the STEAM methodology and visual art in the educational process.

Tasks:

- Organize an awareness campaign in which the community will be encouraged to think about the secondary use of things.
- Organize a virtual exhibition where participants are invited to create unique "Easter decorations" from used items.
- Organize a two-week challenge where communities will try to reduce their waste as much as possible and reuse items.
- Promote recycling and reuse habits through community fairs and activities.
- Strengthen communication and cooperation with the community of pre-school and pre-school education institutions.

III. PARTICIPANTS AND ORGANIZERS

The project participants: children in the preschooler age group, teachers, parents (legal guardians, caretakers).

Organizers: Kaunas kindergarten „Pienė“ temporary director's assistant Leta Dubinskienė, teacher methodologist Ingrida Balickienė, senior teacher Daiva Trečiokienė.

IV. SUBMISSION AND DELIVERY OF WORKS

The project will be organized from 2024 March 25 – April 5.

We create artistic / creative / structural works for the project (bouquets, decorations for indoor and outdoor spaces, etc., responding to the Easter theme) from secondary raw materials while maintaining the idea of sustainable use.

It is necessary to take a photo of the created artistic/creative/constructive work, and upload the digital photos to the virtual closed Facebook group „Easter decoration“ created for the project starting in 2024 March 25 – April 5. When uploading a photo / collage, the name of the educational institution, the group, the educational age, and the teacher's name must be indicated at the top. **The pictures must not show the faces of the students.**

V. FINAL PROVISION

The organizers reserve the right to publish the photos in various publications and websites without informing the author.

Teachers agree that their personal data (name, surname, workplace) will be used to prepare the certificate and include it in the general list.

The participants of the project will receive certificates and letters of gratitude from the organizers, which will be uploaded on the „Easter decoration“ Facebook page.

The organizers reserve the right to not exhibit the submitted endeavours if they do not match the theme of the project and if the quality of the photos are not sufficient.
